Mortgage, Home Equity, Home Improvement, Mobile Home, Signature, Centrix, One-Time Payment, and Share Secured loans, credit cards, and loans 30 or more days delinquent are not eligible for skip-a-payment. New loans funded after 9/30/2009 are also not eligible and all accounts at the credit union must be in good standing. I understand that the interest will continue to accrue during the deferred period. I understand that this will extend my loan. I also understand that skipped payments may affect GAP insurance claims and payments. The \$25 processing fee must be paid prior to payment date and cannot be rolled into the loan balance. Other restrictions may apply.
